The Selüloz, Paper, Wood and Products Workers Union of Turkey (Selüloz İş) , had decided to go to strike with the decisions of its General Board of Directors dated 29.11.2022 and numbered 79 and 80. The strike decision which was announced and communicated by our company will be applied at 08:00 on December 22, 2022 at the production facility located at Kullar Başiskele/KOCAELİ.

Simultaneously with the execution of the strike decision, the production activities of our company located at Başıskele/ Kocaeli address were suspended until the contrary decision was taken.

The personnel assigned in accordance with the relevant legislation will continue to work.

The English translation of this announcement is attached and in case of any difference in the interpretation of the texts, the Turkish version will be accepted as the basis.
